This year the Venice Nano Training School celebrates its 10th anniversary. The event will take place in San Servolo (Venice, Italy) on 22<sup>nd</sup> – 27<sup>th</sup> March 2020.

The School will feature keynote speeches, hands-on sessions and a dedicated Young Scientist Forum Day (23<sup>rd</sup> March) during which early career researchers (PhD students, PhD candidates and Post-Docs) will have the opportunity to present their work. Abstract submissions will open on 10<sup>th</sup> December 2019.

The School week will include a variety of hands-on sessions aimed at transferring state-of-the-art knowledge on a variety of topics from key experts to the next generation of nano-environmental, health and safety, and biomedicine professionals, using interprofessional education.
